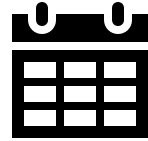




# 2021 Virtual Texas State Conference Exploring Medical Innovation Middle School



## TIMELINE

- March 3:** 2021 Virtual Texas State Conference Registration Deadline

- March 17:** Conference Registration fees due
- March 24:** Virtual Opening Session (see full schedule for the time)
- March 26:** Virtual Grand Awards Session (see full schedule for the time)

- Each team will record a video of its presentation for judges (the one they normally would give in person)
  - Very specific directions for the Recorded Video Presentations have been created. Read this information in detail [HERE!](#)
- Each team will also submit: 1-3 photos of their innovation and exhibit. The photos the team takes are at the team's discretion and should highlight the exhibit and innovation in the best possible way. **Be sure the judges can read what is on the display.**
- Each team will submit: 1) Link to video presentation; 2) 1-3 photos of Innovation and Exhibit; 3) Reference Page
- **The photos and reference page must be uploaded as a single document, pdf preferred,** along with the link to the video presentation by only **ONE** member of the team to [THIS LINK](#). These uploaded materials will be sent to the judges on behalf of the team.
- Uploads must be complete by March 3. The uploaded materials are what the judges will use to score competitors.
- If you do not upload your team materials, there is no content to be judged, therefore no score will be given. Judges will receive materials on March 3 so if you miss the March 3 deadline your material will not be sent to the judges.
- **Pro Tip #1: Do not wait until the last day to upload.** Try to upload your materials before the deadline. If something goes wrong, you have time to troubleshoot!

- **Pro Tip #2: Be sure your pdf file opens and your video link works!** If judges cannot open the file or access the video, they cannot evaluate them. Also, judges should not have to get permission to access your materials.

## TECHNOLOGY NEEDS

- Competitors will need to upload their materials to Wufoo – a smartphone, tablet, or computer are needed to upload.
