After the state advisor has closed out and validated registrations, no refunds can be issued.

## **Academic Testing Center**

One test is complimentary and included in the \$135 ILC registration fee for every HOSA delegate in secondary, postsecondary/collegiate, and alumni divisions. Additional tests are available for \$20 per test. There is no maximum limit to the number of NGL ATC tests that can be taken at ILC if the competitor can logistically sit to test in all events for which they are registered.

## **Registration corrections, additions, or substitutions**

Chapters should NOT email HOSA directly. Only the State Advisor can make corrections, additions, or substitutions to registrations after the May 15 deadline.

## **Outstanding Affiliation Fees and Conference Registration Fees**

All previous outstanding balances such as affiliation fees and State Conference fees must be paid before you register for ILC.
