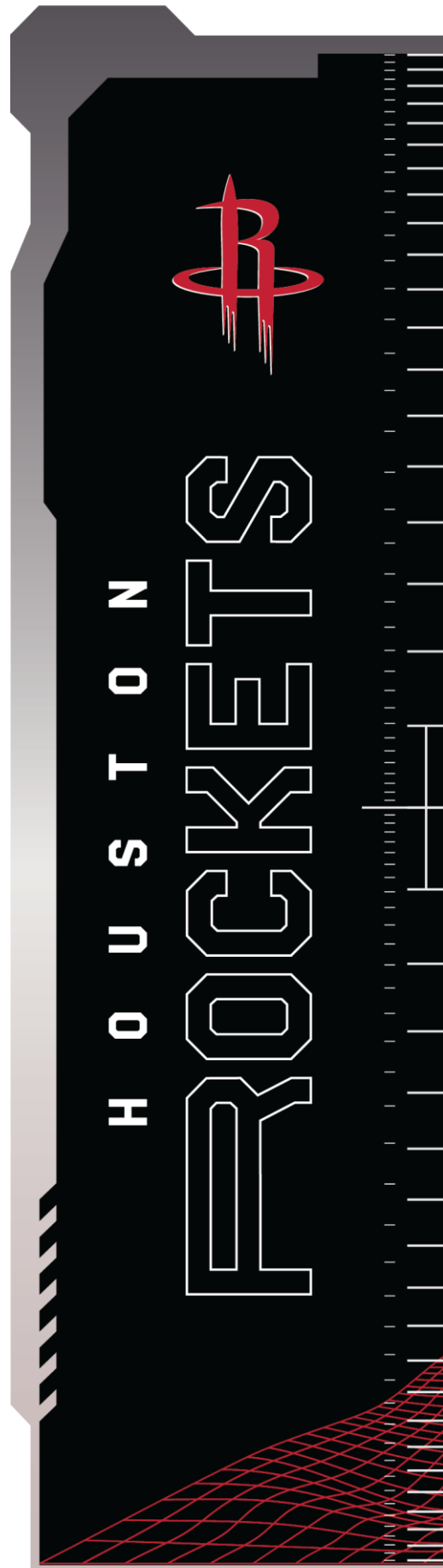

## HOSA DAY AT THE ROCKETS

**Wednesday, November 6, 2024**

### **12:00 – 12:30 Drop-Off at Bell St. Entrance (same location for pick-up)**

*When you arrive to the Toyota Center at the Bell Street Entrance, if the doors are not open yet, please leave the students on the bus and have the group leader proceed to the check-in table outside of the arena. I will be collecting the following:*

- Signed Release Forms (any students who do not have a waiver signed by a parent/guardian will not be able to participate in the free-throw and group photo on the court)
- Payment for those paying the day-of with credit card, school check, or cash
  - *Your game tickets will be sent to your app once the payment is processed.*

*When the doors are officially opened, those who have already checked in, can enter the building with your students. Group Leaders can grab your goodie back at the table.*

*If you have not checked in yet, you can enter and proceed to the check-in table indoors. I will be collecting the following:*

- Signed Release Forms (any students who do not have a waiver signed by a parent/guardian will not be able to participate in the free-throw and group photo on the court)
- Payment for those paying the day-of with credit card, school check, or cash
  - *Your game tickets will be sent to your app once the payment is processed.*
- *Goodie bag available at the check-in table*

### **This is a good time for a restroom break if needed!**

**12:30 – 2:00 – Program:** After you've checked in, the schools will be called out and escorted down to the lower bowl for the program to include a Q&A and panel discussion staff and health industry professionals.

**2:00 -3:00 – Free-throw/Photo:** Schools will be called down to the court for your Free-Throw and subsequent group photo on the court. Teachers can take a shot too!

After your group photo, you can exit to the main concourse/Bell St. Entrance. Please, no hard sole shoes or high heels on the court.

6:00 – Return to Toyota Center for the game. Tip-off at 7pm

**Notes:** *Please make sure you have your tickets in your app for the game. If you have paid in full, and do not see them, make sure you have downloaded the newest version of the app (Houston Rockets or AXS app) to view and/or transfer your tickets.*

*All point of sales at Toyota Center are now cashless. Guests should prepare to use a bank card or contactless payment option. This applies to both concessions and the Team Shop.*

## **Reminders:**

- Bag policy no bags larger than 14x14 are allowed in. **No Backpacks are allowed, regardless of the size.**
- No food or drink can be brought into the arena. This goes for both the event and the Rockets game.

## RELEASE AND INDEMNITY AGREEMENT

I, the undersigned, wish to participate or have my child or ward participate (any such participant referred to herein as the “Participant”) in **HOSA Day at the Rockets**, which will be held at **Toyota Center**, located at **1510 Polk St., Houston, TX 77002**, on **November 6, 2024**, and which could involve physical activity before, during and after the event (collectively, the “Activity”). I understand that there is a risk that Participant will be injured before, during or after, or as a result of or in connection with the Activity (including transportation to and from the Activity), and I wish for Participant to participate in the Activity despite the risk involved. Further, I, on behalf of Participant, voluntarily assume all risk and danger of personal injury, virus or disease contraction, death, and all hazards arising from, or related in any way to, the Activity, whether occurring prior to, during or after the Activity, howsoever caused and whether by negligence or otherwise.

As consideration for Participant being allowed to participate in the Activity, I, for myself, Participant (if not myself), and each of our respective successors, administrators, heirs and assigns, hereby **RELEASE, ACQUIT, AND FOREVER DISCHARGE** Rocket Ball, Ltd. d/b/a the Houston Rockets; Fertitta Sports Entertainment, LLC; TJF Rocket Ball, Inc.; Fertitta Entertainment, Inc.; Landry’s, LLC; Clutch City Sports & Entertainment, L.P.; SportsNet Southwest, LLC; TJF CCSE, LLC; the National Basketball Association and all of its member teams and operators; NBA Properties, Inc.; Harris County-Houston Sports Authority; the owner(s) and operator(s) of the venue(s) where the Activity is to be held; any corporate partner and/or sponsor of the Activity; the other participants in the Activity; and all of the respective past, present and future officers, partners, members, managers, directors, attorneys, insurers, agents, servants, suppliers, dealers, representatives, employees (including, without limitation, any employee who acts as the mascot of the Houston Rockets), coaches, trainers, parent companies, affiliates, subsidiaries, predecessors- and successors-in-interest, and assigns of the foregoing (collectively referred to herein as the “Released Parties”) from all past, present and future claims arising out of and accruing to Participant for or in any way connected with any damages sustained by Participant before, during or after, or as a result of, or in any way connected with, the Activity (including transportation to and from the Activity), including actual or punitive damages for personal injury, dismemberment, death, or virus or disease contraction (including, without limitation, severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2), which is also known as COVID-19 (“COVID-19”) sustained in Participant’s participation in the Activity (including transportation to and from the Activity), and all results thereof, past, present and future, known and to become known, accrued and to accrue, and **INCLUDING ANY CLAIMS OF THE RELEASED PARTIES’ NEGLIGENCE, GROSS NEGLIGENCE, STRICT LIABILITY OR WILLFUL CONDUCT (REGARDLESS OF WHETHER THE RELEASED PARTIES ARE SOLELY, JOINTLY, OR CONCURRENTLY NEGLIGENT OR OTHERWISE AT FAULT)**.

As a further inducement to the Released Parties, I, for myself, Participant (if not myself), and each of our respective successors, administrators, heirs and assigns, have agreed to and do hereby **INDEMNIFY, DEFEND AND HOLD HARMLESS** each and all of the Released Parties from and against any and all past, present and future claims, demands, actions and causes of action, of whatsoever nature or character, **INCLUDING CLAIMS OF THE RELEASED PARTIES’ NEGLIGENCE, GROSS NEGLIGENCE, STRICT LIABILITY OR WILLFUL CONDUCT (REGARDLESS OF WHETHER THE RELEASED PARTIES ARE SOLELY, JOINTLY, OR CONCURRENTLY NEGLIGENT OR OTHERWISE AT FAULT)**, which may hereafter be asserted by any person, firm or entity whomsoever, arising out of and accruing to Participant for or in any way connected with any damages sustained by Participant before, during or after, or as a result of, or in any way connected with, the Activity (including transportation to and from the Activity), including actual or punitive damages for personal injury, dismemberment, death, or virus or disease contraction (including, without limitation, COVID-19) sustained in Participant’s participation in the Activity (including transportation to and from the Activity), and all results thereof, past, present and future, known and to become known, accrued and to accrue. This obligation to indemnify and hold harmless specifically includes, but is not limited to, any claims for medical bills and any other expenses incurred by Participant that are in any way related to the Activity.

As a further inducement to the Released Parties, I hereby represent and warrant to the Released Parties that:

- (1) I thoroughly and completely understand that this is a complete and final release and indemnity agreement concerning any claim, demand, or cause of action that I or Participant (if not myself) may have against the Released Parties related to or in any way arising out of the Activity (including transportation to and from the Activity);
- (2) I am entering into this Release and Indemnity Agreement (the “Agreement”) freely and voluntarily;
- (3) no representations, promises or statements made by any agent, attorney or other representative of the Released Parties have influenced me in causing me to sign this Agreement;

- (4) Participant has adequate medical insurance provided by parties other than the Released Parties covering the possible injuries to Participant that may occur as a result of Participant's participation in the Activity (including transportation to and from the Activity);
- (5) Participant does not have any physical condition or illness that would be aggravated by participation in the Activity or that would make participation in the Activity medically inadvisable;
- (6) I am at least eighteen (18) years of age as of the date of this Agreement;
- (7) if I am signing on behalf of a minor named herein as Participant, I have the legal capacity and authority to act for and on behalf of such minor, and I agree to **INDEMNIFY, DEFEND AND HOLD HARMLESS** each and all of the Released Parties for any claims or liabilities assessed against them as a result of any insufficiency of my legal capacity or authority to act for and on behalf of Participant in the execution of this Agreement; and
- (8) I hereby authorize any emergency medical care on Participant as may be necessary if such need arises. I realize and appreciate that there is a possibility of complications and unforeseen consequences in any medical treatment, and I assume any such risk for and on behalf of myself and Participant.

I hereby grant to the Released Parties, with no obligation to compensate me, Participant (if not myself), or any other person in any way, the perpetual and irrevocable license to publish, reproduce, modify, display, distribute, sublicense or otherwise use, commercially or otherwise (including in connection with any publicity, marketing and promotion), in any media now existing or later developed, Participant's name and any photographs, videotapes, motion pictures, recordings, or other record of Participant's participation before, during or after the Activity. I understand that Participant's name, image or likeness may be modified, copied and distributed by means of various media, including, but not limited to, the Toyota Center in-arena scoreboard, Space City Home Network, news bulletins, mail outs, television, media broadcasts, billboards, signs, brochures, placement on the internet, the Houston Rockets' website, social media, or other electronic delivery, or publication. I acknowledge that the Released Parties have the right to use one or more electronic reproductions of Participant's name, image or likeness in accordance with this Agreement. Participant waives any right to inspect or improve the finished product, or any material in which the Released Parties will eventually use Participant's name, image or likeness. Further, I understand that Participant's involvement in the Activity may be captured on media and used by third parties, and that the Released Parties shall have no control over (and shall have no obligation to control) the use of Participant's name, image or likeness by any such third parties. **By signing this Agreement, each Parent/Guardian and/or Participant who is at least thirteen (13) years old as of the time they enter into this Agreement agrees to: (i) be bound by the NBA's privacy policy located here: <https://www.nba.com/privacy-policy>; and (ii) receive marketing communications from the Released Parties, subject to opting out when the Parent/Guardian and/or Participant so desires.**

I agree that any dispute ("Dispute") arising out of or related to this Agreement, the relationship of me, Participant and the Released Parties under this Agreement and/or Participant's participation in the Activity will be settled by binding arbitration conducted in Houston, Texas, in accordance with the then-current JAMS Comprehensive Arbitration Rules & Procedures. The arbitrator shall not have the authority, power or right to alter, change, amend, modify, waive, add to or delete from the provisions of this Agreement. The prevailing party in such arbitration shall be entitled to recover such party's costs and attorneys' fees related to the arbitration from the non-prevailing party, and the costs and expenses of the arbitrator shall be paid for by the non-prevailing party in the arbitration. **EACH PARTY WAIVES THE RIGHT TO LITIGATE IN COURT OR ARBITRATE ANY CLAIM OR DISPUTE AS A CLASS ACTION, EITHER AS A MEMBER OF A CLASS OR AS A REPRESENTATIVE, OR TO ACT AS A PRIVATE ATTORNEY GENERAL.**

I understand that in allowing Participant to participate in the Activity, the Released Parties are relying on the representations and warranties I have made herein. This Agreement shall be governed by the laws of the State of Texas (without regard to conflict-of-laws principles). If any provision of this Agreement is held to be invalid or unenforceable, that holding shall be without effect upon the validity or enforceability of any other provision of this Agreement.
