### **Event Summary**

Outstanding HOSA Alumni is designed to honor HOSA alumni for their membership in HOSA-Future Health Professionals and outstanding leadership in the healthcare industry or in a graduate health program. Each HOSA Alumni selected will be recognized at the HOSA International Leadership Conference and on the HOSA website.

#### **General Rules**

- Applicants must be a registered member of the HOSA International Alumni Association (HIAA). To register as an alumnus, go to: <a href="https://hosa.org/alumni/">https://hosa.org/alumni/</a>
- 2. Applicants must be at least 3 years past their high school graduation year to be eligible. For example, an alumnus who graduated high school in 2022, would first be eligible for this recognition at the 2025 ILC.
- 3. Alumni can only receive this recognition one time.
- 4. This recognition event is only judged at the international level and will not be judged at the regional or Chartered Association (state) level. States may have their own process for recognizing alumni.
- 5. There is no limit to the number of entries for this event from a Chartered Association.
- 6. This event is a self-nomination/application by the alumni member.
- Alumni members do not need to register for this recognition with ILC conference registration. Recognition
  will be presented at ILC; however, applicants are not required to attend ILC to be eligible for
  consideration.

#### **Submission**

- 9. Outstanding HOSA Alumni applicants will register for this recognition event by completing the online form HERE.
- 10. The online submission form asks the applicant for the following information:
  - A. Contact Information: Name, Address, Email, Phone
  - B. Headshot to be used in HOSA marketing and recognition purposes
  - C. The following items must be addressed and uploaded in a maximum 3-page document:
    - i. What was the benefit to you of participating in HOSA?

- ii. Describe your educational journey.
- iii. Describe your employment history as it relates to healthcare. If you are in a graduate program, it is acceptable to include any volunteer work or other experiences related to your field of study.
- iv. Describe your achievements and accomplishments as related to healthcare.
- v. How have you continued to support and be involved with HOSA since becoming an alumni member? Activities may include event judging, judge recruitment, guest speaking, Advisory Board member, conducting workshops, financial support, serving as a mentor to a HOSA member, or service on local, state, or national level committees and boards, etc.

11. Applications for Outstanding HOSA Alumni are due by midnight May 15, 2025 and will be reviewed by a panel of judges.

#### **Scoring and Award**

- 12. HOSA Alumni achieving the minimum standard of 80% or greater will be recognized with a plaque at the ILC and listed on the HOSA website.
- 13. Those earning recognition but not attending the ILC will receive their award via UPS.
